Dear First Amendment Advocate:

Sixteen years after 9/11, on which side of history will you find yourself?

Most people we have asked are not aware that a third tall building at the World Trade Center collapsed in New York City on September 11, 2001. The building was WTC Building 7 located north of the North Tower (WTC 1). Building 7 was 47 stories high, had a footprint about the size of a football field and collapsed into its own footprint at 5:20 p.m. on 9/11 in less than 7 seconds.

WTC Building 7 was not hit by a plane; was not seriously damaged by the collapse of the Twin Towers that morning; and was omitted entirely from the 9/11 Commission Report, which came out in 2004.

The official explanation for the mysterious collapse of WTC Building 7 was provided in 2008 by the National Institute of Standards and Technology (NIST). NIST, in its report, concluded that ordinary office fires caused the nearly free-fall collapse of Building 7 at the World Trade Center on 9/11 in less than 7 seconds. This explanation is not accepted by most people who have looked into this matter, including almost three thousand architects, structural engineers, other engineers, scientists, academics and building demolition experts.

You have been chosen to receive this letter with its enclosures, because we would like you to watch the DVD which focuses on the collapse of Building 7 and return your answers to the 4 questions on the enclosed post card. We have included the list of the recipients who have received this mailing for your information and possible follow-up.

Perhaps you are wondering why your name is included on this mailing list. We are seeking to hear back from well-known local and national media persons, journalists, academics, politicians, and investigators who may or may not know about the collapse of WTC Building 7. We have tracked the delivery of this Priority Mailing to the address we listed for you, so that we can credibly evaluate data we receive back on the enclosed prepaid post cards.

We will record and analyze the data resulting from this mailing. We intend to publicize our analysis as broadly as possible. We will be happy to share with you this data, our analysis, and a list of those who responded to the mailing, if you so indicate on the post card.

Thank you for your attention to this very important matter and please respond before September 11<sup>th</sup> if possible.
